NOTICE IS HEREBY GIVEN that sealed bids will be received by the City Clerk of the City of Vista for furnishing all labor, materials, and all other items and facilities necessary therefore, as provided in the Contract Documents, for the **GLORIA MCCLELLAN ADULT ACTIVITY & RESOURCE CENTER EXTERIOR RENOVATION FOR ACCESSIBILITY (CITY PROJECT NO. B16-1109)** in strict accordance with the Project Specifications and Plans on file at the City of Vista's Development Services Division.

Bids will be received at the Office of the City Clerk, Vista Civic Center, 200 Civic Center Drive, 2nd Floor, Vista, California 92084, until **2:00 P.M. on Monday, August 21, 2017**, at which time the bids will be publicly opened and read aloud. Bids shall be submitted in a sealed envelope with the title of the project plainly marked on the outside: "**GLORIA MCCLELLAN ADULT ACTIVITY & RESOURCE CENTER EXTERIOR RENOVATION FOR ACCESSIBILITY**".

The project site is located at the Gloria McClellan Adult Activity & Resource Center – 1400 Vale Terrace Drive, Vista, CA 92084. The work to be included in the bid consists of: furnishing all materials, equipment, tools, labor and incidentals as required in the specifications and contract documents for the following project(s): GLORIA MCCLELLAN ADULT ACTIVITY & RESOURCE CENTER EXTERIOR RENOVATION FOR ACCESSIBILITY. Scope of work includes: demolishing existing terrace, demolishing portion of retaining wall, new accessible terrace and new ADA compliant accessible ramp, railing, and retaining wall.
