NOTICE INVITING BIDS**

NOTICE IS HEREBY GIVEN that sealed bids will be received by the City Clerk of the City of Vista for furnishing all labor, materials, and all other items and facilities necessary therefore, as provided in the Contract Documents, for the **WAVE WATERPARK SPRAY GROUND REPLACEMENT PROJECT (C.I.P. NO. 8265/BUILDING PLAN NO. B17-0792)** in strict accordance with the Project Specifications and Plans on file at the City of Vista's Development Services Division and Recreation & Community Services Department.

Bids will be received at the Office of the City Clerk, Vista Civic Center, 200 Civic Center Drive, 2nd Floor, Vista, California 92084, until **2:00 P.M.** on **Wednesday, November 15, 2017**, at which time the bids will be publicly opened and read aloud. Bids shall be submitted in a sealed envelope with the title of the project plainly marked on the outside: "**WAVE WATERPARK SPARY GROUND REPLACEMENT PROJECT (C.I.P. NO. 8265/BUILDING PLAN NO. B17-0792)**".

The project site is located at the Wave Waterpark – 101 Wave Drive, Vista, CA 92083. The work to be included in the bid consists of: removal/demolition of the existing water play structure, portion of pool decks to limits shown, mechanical equipment to limits shown, water play perimeter pool fence upgrades, and all other miscellaneous items shown on the plans. Construction of new water play area, pool decks, piping, equipment, fenced equipment enclosure, setting of all mechanical equipment, water play elements and finishes as shown on plans. All other items as required to provide a completely operational aquatic facility. In addition, work of this contract generally consists of: demolition, new construction and such other items not mentioned that are required by the Contract Documents, law and governmental codes and regulations.

The architect's cost estimate is \$526,382. Bid documents will be available for inspection without charge at the City of Vista's Development Services Division, 200 Civic Center Drive, Vista, CA 92084.
