

ORDINANCE NO. 2018-3

AN ORDINANCE OF THE CITY COUNCIL OF THE CHARTERED CITY OF VISTA, CALIFORNIA, ESTABLISHING PROCEDURES FOR SETTING THE DATES FOR REGULAR CITY COUNCIL MEETINGS

The City Council of the City of Vista does ordain as follows:

1. Findings.

A. Article 11, Section 7, of the California Constitution provides that a city may make and enforce within its limits all local, police, sanitary, and other ordinances and regulations not in conflict with general laws. This ordinance is enacted pursuant to that section.

B. Section 43954 of the California Government Code provides that the legislative body of a local agency, except for advisory committees or standing committees, shall provide, by ordinance, resolution, bylaws, or by whatever other rule is required for the conduct of business by that body, the time and place for holding regular meetings. This ordinance is enacted pursuant to that section.

2. Code Amendment.

A. Subsection A of Section 2.12.030 (Meetings and Workshops—Time and Location) of Chapter 2.12 (City Council) of Title 2 (Administration and Personnel) of the Vista Municipal Code is amended to read as follows:

“A. Regular meetings of the City Council shall be held on the first, second, and fourth Tuesdays of each month except as otherwise provided below.

1. The City Council shall annually adopt one or more resolutions identifying the dates on which regular meetings shall be held. Dates not identified by the City Council shall not be regular meeting dates for any legal purpose.

2. Any scheduled regular meeting may be cancelled by the City Manager in consultation with the Mayor.

3. Regular meeting dates established by the City Council shall also be regular meeting dates for the Community Development Commission, the Buena Sanitation District, and the Successor Agency.

4. If the City Council does not adopt a resolution establishing meeting dates for a given month or calendar year, regular meetings shall be held on the first, second, and fourth Tuesdays of the month.”

3. Effective Date. This Ordinance shall be effective on the 31st day following the date of its adoption. The City Clerk shall cause this ordinance to be published in the manner required by law.
