**PROPOSED 2018-2019 ANNUAL ACTION PLAN**

NOTICE IS HEREBY GIVEN that the City of Vista held a public hearing on March 13, 2018, and opened a 30-day public comment period to receive testimony on the proposed 2018-19 Community Development Block Grant Annual Action Plan (Plan). **After considering public comments, the City Council will vote on the final Plans on April 24, 2018, in the City Council Chambers, Vista Civic Center, 200 Civic Center Drive, Vista, CA 92084.** The Annual Action Plan identifies proposed uses for the City's anticipated allocation of \$770,000 of Community Development Block Grant (CDBG) funds. The City of Vista will use CDBG and other funds to help achieve the housing and community development objectives identified in the City's 2015-2019 Consolidated Plan and Annual Action Plan. The Plans address citizen participation, housing and community development needs, constraints to the provision of housing, strategic plan, goals and priorities, available resources, fair housing, anti-poverty strategy, lead based paint, and institutional structure.

The proposed activities for FY 2018/19 CDBG funds are:

**Public Service Projects:** A total of nine projects are recommended to receive funding under the Public Service category. Services include: emergency shelter; crime and delinquency prevention programs, support services for seniors, health services (including mental health), and emergency assistance.

**Capital Projects:** Funding is recommended for design and construction of sidewalks in low-income neighborhoods.

**Administration and Fair Housing:** Funds are also used for administration services, as well as the Fair Housing program.

All activities will benefit low-income persons as required by the Department of Housing & Urban Development. Copies of the proposed Plan is available at the City Clerk's Office, Vista Library, and on the City's website [cityofvista.com](http://cityofvista.com).
