

City of Vista Climate Action Plan Update Community Meeting #1 June 4, 2018

Write-In Ideas:

- Ban single-use plastics
- Require annual reporting of city progress towards CAP
- Create an Environmental Commission or Environmental Committee
- Incorporate zoning for urban farming and community gardens
- Support zero-waste programs to educate our future leaders
- Require developers to fully offset construction emissions
- Incorporate rooftop gardens on multi-story residential buildings
- Adopt-a-block litter abatement with businesses (as in Long Beach)
- Collaborate with countywide cities on common measures which affect all
- Incorporate permaculture-style municipal rainwater/stormwater collection/usage
- Include an equity clause for all implemented CAP measures to ensure public funds are spent to further equity and wellbeing throughout the City of Vista
- Enhance education and outreach through partnerships with VUSD, non-profits, organizations, and cultural centers and events
- Require mandatory reach codes for new and existing construction (% better than energy code EDR)
