Adult Men's, Women's & Coed Softball Program

The City of Vista Recreation & Community Services Department will welcome Adult Men's, Women's Coed softball registrations beginning Monday, January 2, 2019. This packet contains all the necessary materials to register a team. Registration is on a first come first serve basis, divisions will fill at which point we will suggest an alternate night or division of play. Paid teams will have priority during registration for scheduling and all games .

Fees

- **Vista Resident/Business or Military Team.....\$484**
A Vista Resident Team is a team with no more than two (2) non-residents on the roster.***
A Business Team is comprised entirely of employees or has their league fees paid by a Business sponsoring the team. Military teams are comprised of Active Duty participants
- **Business League.....\$300**
All teams must be comprised of entirely of employees (proof required)
- **Non-Resident Team.....\$580**
A Non-Resident team is a team with more than two (2) non-residents on the roster.
- **Resident/Non-Resident Mid Season Rate (6 Games).....\$242/\$290**
Deadline for enrollment is Mid-season, call for exact date

Additional Fees

- Umpire Fees: \$15 per team, per game. These fees are payable at the game site in cash per team.
- Forfeit Fee: A forfeit fee of \$30 is required when registering your team. In addition, any team who fails to pay their forfeit fees may not play in their next game.
- There will be a \$5.00 charge for each player additions after the season has begun..

A resident is defined as someone who lives within the City limits of Vista.

League Dates

- Placement games will start the week of March 4th. League Games will start the week of March 11th
- Not all teams will get placement games, due to field limitations and weather.

Managers Meetings

All teams participating in the Spring 2019 softball season must have the manager or a team representative attend one of the (2) mandatory managers meetings. Meetings last about 30-45 minutes.

League Format

- Divisions: Men's, Women's & Coed, Men's 35 & Older, Senior 50 & Older, Business League— most divisions have beginner, intermediate & advanced leagues.
- The season is comprised of 1 or 2 placement games, 10-12 league games, (two halves of round robin play) and a single elimination playoff game for the top 2 seeds from each half. Winning teams will play in a championship game.
- Games are played Sunday through Friday evenings at Brengle Terrace, Breeze Hill and Buena Vista Parks. Once placed in a league, a team will play on one specific night, unless unforeseen circumstances occur.

Registration Procedures

- Registration begins **Monday, January 2nd, 2019**. Registrations are accepted on a first come, first serve basis and space is limited. Teams are encouraged to submit their registration packet as early as possible, since certain nights fill fast. Registrations will be accepted through **Monday, March 11th, 2019** or until the program/division is full.
- Teams may pick-up and/or submit a registration packet at City Hall, 200 Civic Center Dr., Monday– Friday 10:30am-5pm and online @ www.vistarecreation.com. For your convenience, a completed registration packet may also be mailed to the City of Vista – 200 Civic Center Dr., Vista Ca 92084 Attn : Adult Sports Office or by fax (760)643-2897 using your credit card (see sign-up sheet for fax instructions). Cash, check, Visa and MasterCard are accepted.
- **A complete team registration will consist of :** (1) A team roster with all players signatures and addresses, verification of residency for all Vista residents (Vista Resident teams only) and (2) The appropriate league fee (check, cash, Visa or MasterCard). All of the above mentioned items must be submitted at the same time. If the registration lacks one of the above items, no space in the program will be secured and no placement game will be assigned until the registration is completed.
- Teams are allowed to select a preferred night. However, there is no guarantee as to what night and / or division a team will play in prior to the completion of the placement games. All preferences as to night / division must be relayed to the league director prior to the start of the placement games. There is no guarantee that requests will be accommodated. Below is a tentative break down of the divisions, leagues and nights of play. Please take this into account when selecting a night.

EXPRESS ASSUMPTION OF THE RISK

Recreational sports and activities *INVOLVE INHERENT RISKS OF SERIOUS NJURY, DEATH OR PROPERTY DAMAGE* that no amount of care, caution, instruction, or expertise can eliminate. Participation in recreational sports and activities *ALSO EXPOSES ONE TO ADDITIONAL RISKS*, whether inherent or not, caused by things such as conditions of property, equipment provided or conduct of others, including other participants, spectators, or employees/agents/independent contractors of the City of Vista. These risks can be encountered whether or not actually participating in the recreational sport or activity. *PARTICIPANT FREELY ASSUMES ALL RISKS WHETHER OR NOT SPECIFICALLY DELINEATED.*

RELEASE AND WAIVER OF LIABILITY

In consideration for permission to participate in the program, the undersigned agrees to *FOREVER RELEASE, DISCHARGE, AND WAIVE ANY AND ALL LIABILITY CLAIMS OR DEMANDS AGAINST THE CITY OF VISTA* or their employees/agents/independent contractors/volunteers ("Releasees") that the *UNDERSIGNED, HIS OR HER PERSONAL REPRESENTATIVE(S), SUCCESSOR(S) IN INTEREST, ASSIGN(S), HEIR(S), OR DEPENDENT(S)* has or might have against Releasees, whether or not caused by the negligence of Releasees or any other person or entity, arising out of participation in the program.

INDEMNITY

In consideration for permission to participate in the program, the *UNDERSIGNED, HIS OR HER PERSONAL REPRESENTATIVE(S), SUCCESSOR(S) IN INTEREST, ASSIGN(S), HEIR(S), or DEPENDANT(S)* *AGREE TO INDEMNIFY, HOLD HARMLESS AND DEFEND* Releasees from any legal obligation or liability, whether or not caused by the negligence of Releasees or any other person or entity, arising out of participation in the program. The duty to defend exists independently of any duty to indemnify.

ACKNOWLEDGEMENT

By signing the team registration form *THIS EXPRESS ASSUMPTION OF THE RISK, RELEASE, WAIVER, AND INDEMNITY AGREEMENT ("AGREEMENT")*, the undersigned acknowledge(s) that: (1) participation in recreational sports and activities is voluntary and does not involve public interests; (2) that the *AGREEMENT* has been read and understood; and (3) that the *AGREEMENT is a contract that EXTINGUISHES CERTAIN LEGAL RIGHTS AND IMPOSES OTHER LEGAL OBLIGATIONS.* Failure to initial where indicated above does not invalidate the *AGREEMENT.* Additionally, if the Participant is a minor his or her custodial parent or legal guardian must read and execute this *AGREEMENT* and by signing agrees to be bound by the *AGREEMENT* and agrees to bind the minor to the *AGREEMENT.*
