NOTICE OF PUBLIC HEARING OF THE CITY COUNCIL  
PROPOSED 2019-2020 ANNUAL ACTION PLAN**

NOTICE IS HEREBY GIVEN THAT the City of Vista will hold a public hearing on **March 26, 2019, at 5:30 p.m.** in the City Council Chambers, Vista Civic Center, 200 Civic Center Drive, Vista, CA 92084, to review the proposed 2019-2020 Annual Action Plan. The purpose of the hearing is to open a 30-day comment period, obtain citizen views, and respond to questions regarding the Plan. After considering public comments, a second meeting will be held on April 23, 2019, at 5:30 p.m. in the City Council Chambers, Vista Civic Center, at which time the City Council will consider approval of the final Plan.

The Annual Action Plan identifies proposed uses for the City's anticipated allocation of \$953,355 of Community Development Block Grant (CDBG) funds. The City of Vista will use CDBG and other funds to help achieve the housing and community development objectives identified in the City's 2015-2019 Consolidated Plan and Annual Action Plan. The Plans address citizen participation, housing and community development needs, constraints to the provision of housing, strategic plan, goals and priorities, available resources, fair housing, anti-poverty strategy, lead based paint, and institutional structure.

All activities will benefit low/moderate income persons as required by the Department of Housing & Urban Development (HUD). All activities will be reviewed to ensure that any necessary relocation assistance for temporary or permanently displaced persons is given according to federal regulations and the City's relocation policy. Copies of the City's proposed 2019-2020 Annual Action Plan will be made available at the Vista Civic Center, Vista Library, and on the City's website, [cityofvista.com](http://cityofvista.com) as of March 16, 2019.
